

RESOLUTION TO CANVASS VOTE

RESOLUTION NO. 11-955

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CHINO VALLEY, COUNTY OF YAVAPAI, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON MARCH 8, 2011

WHEREAS, the Town of Chino Valley, Yavapai County, Arizona did hold a primary election on the 8th day of March, 2011 for the election of a Mayor and three (3) Councilmembers; and

WHEREAS, the election returns have been certified by the Yavapai County Election Director and Yavapai County Recorder; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council; and

WHEREAS, the Town Council is adopting this Resolution, No. 11-955, to canvass the vote at this Regular Meeting, being held today, March 22, 2011;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Chino Valley, Yavapai County, Arizona as follows:

Section 1. That the total number of ballots cast at said primary election, as shown by the poll lists, was 2,256.

Section 2. That the number of ballots rejected was 18.

Section 3. That the votes cast for the candidates for councilmember were as follows:


