

RESOLUTION NO. 2022-1219

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CHINO VALLEY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 2, 2022.

WHEREAS, the Town of Chino Valley, Arizona, held a primary election on August 2, 2022, for (i) the nomination or election of a Mayor and three Councilmembers and (ii) approval of a Utility Franchise Agreement with Arizona Public Service Company; and

WHEREAS, the election returns were certified by the Yavapai County Election Director and Yavapai County Recorder, a true and correct copy of which certification is attached hereto as Exhibit A, and incorporated herein by this reference; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Chino Valley, Yavapai County, Arizona as follows:

SECTION 1. The recitals above are hereby incorporated as if fully set forth herein.

SECTION 2. The total number of ballots cast at said primary election, as shown by the poll lists or reported by the county, was 4,103.

SECTION 3. The number of ballots rejected was 38.

SECTION 4. The total number of votes cast at said primary election for each office and each ballot measure, as shown by the poll lists, was:

Question 1:	3,661

SECTION 7. In order to comply with ARIZ. REV. STAT. § 16-642, it is necessary for this Resolution to be immediately effective. Accordingly, pursuant to Section 36.04 of the Chino Valley Town Code, this Resolution shall be in full force and effect immediately upon its adoption by 3/4 vote of all of the members of the Council.


