

**RESOLUTION NO. 2025-1279**

**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CHINO VALLEY, ARIZONA, ESTABLISHING SPEED LIMITS ON EAST PERKINSVILLE ROAD BETWEEN STATE ROUTE 89 AND PINTO LANE.**

**WHEREAS**, Ariz. Rev. Stat. § 28-703 and Chino Valley Town Code § 71.12 authorize the Mayor and Common Council of the Town of Chino Valley to alter speed limits within the Town based on the results of engineering and traffic investigations; and

**WHEREAS**, in accordance with the Manual on Uniform Traffic Control Devices (MUTCD), as modified by the Arizona Supplement to the MUTCD, the Public Works/Engineering Department conducted an engineering and traffic investigation on East Perkinsville Road between State Route 89 and Pinto Lane, resulting in a recommendation of 30 MPH.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of the Town of Chino Valley, Arizona, as follows:

**SECTION 1.** The recitals above are hereby incorporated as if fully set forth herein.

**SECTION 2.** The report from the engineering and traffic investigation, titled “East Perkinsville Road Speed Study Final Report,” dated February 6, 2025, is to be maintained in the files of the Public Works Department per Town Code § 71.12 and is hereby accepted.

**SECTION 3.** The speed limit for East Perkinsville Road between State Route 89 and Pinto Lane will be 25 mph.

**SECTION 4.** All resolutions or parts of resolutions in conflict with the provisions of this Resolution are hereby repealed.

**SECTION 5.** If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

**SECTION 6.** The Mayor, Town Manager, Town Attorney, and Public Works Director are authorized and directed to execute all documents and take all steps necessary to carry out the purpose and intent of this resolution.
