

**RESOLUTION TO CANVASS VOTE**

**RESOLUTION NO. 14-1050**

**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CHINO VALLEY, COUNTY OF YAVAPAI, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION HELD ON NOVEMBER 4, 2014**

WHEREAS, the Town of Chino Valley, Yavapai County, Arizona did hold a special election on the 4th day of November, 2014 for (1) a question of selling and issuing bonds payable from secondary (ad valorem) property taxes; and (2) ratification of the "Town of Chino Valley General Plan 2014;" and

WHEREAS, the election returns have been certified by the Yavapai County Election Director and Yavapai County Recorder; and

WHEREAS, the election returns have been presented to and have been canvassed by the Town Council; and

WHEREAS, the Town Council is adopting this Resolution No. 14-1050, to canvass the vote at this Rescheduled Regular Meeting, being held today, November 18, 2014;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Town of Chino Valley, Yavapai County, Arizona as follows:

Section 1. That the total number of ballots cast at said special election, as shown by the poll lists, was 3,587.

Section 2. That the number of ballots rejected was 43.

Section 3. That the votes cast for the question of selling and issuing bonds payable from secondary (ad valorem) property taxes were as follows:

Yes	1,106
No	2,337

Section 4. It is hereby found, determined and declared of record, that the question of selling and issuing bonds payable from secondary (ad valorem) property taxes did not receive the majority of the total number of valid votes cast and hereby shall not be authorized.

Section 5. That the votes cast for the "Town of Chino Valley General Plan 2014" were as follows:



and hereby shall be adopted as the General Plan for the Town of Chino Valley pursuant to A.R.S. Section 9-461 et. seq.

Section 7. All resolutions in conflict herewith are hereby repealed, and this resolution shall be in full force and effect immediately upon its adoption.




