

NOTICE AND CALL FOR BIDS
FY 2023 STREET IMPROVEMENTS PROJECT
Town of Chino Valley, AZ

DESCRIPTION: Construction work, in general, consists of furnishing all labor, materials, equipment, and services for the reconstruction of the following roadway segments:

- Cantfield Ave between W Perkinsville Rd and end of cul-de-sac (3" AC)
- Taylor Ave between W Perkinsville Rd and end of cul-de-sac (3" AC)
- Campbell Ave between W Perkinsville Rd and end of cul-de-sac (3" AC)
- E Rd 1 South between SR-89 and S Road 1 East (4" AC / 9" AB)
- S Rd 1 East between Fletcher Ct and E Rd 3 South (4" AC / 9" AB) including new 18" sewer main with appurtenances

The estimate of probable cost is \$3.5M - \$4.5M

BID BOND: All bidders desiring to prepare a responsive bid shall submit a non-revocable bid security payable to the Town in the amount of ten percent (10%) of the total bid price per the contract documents.

BID OPENING: Sealed bids, clearly marked with the bidder's name and project name, will be received Tuesday, April 11, 2023 at 3:00 p.m. at the Public Works Department, 1982 Voss Dr., Chino Valley, AZ 86323. Any bid received after the time specified will be returned unopened. It is the bidder's responsibility to assure proposals are received at the above location on or before the specified time.

RIGHT TO REJECT BIDS: The Town reserves the right to reject any or all bids, waive any informality in a bid or to withhold the award for any reason the Town determines.
